# **VANCOUVER THUNDERBIRDS TRACK AND FIELD CLUB WAIVER AND PERMISSION CLAUSE**

## **CODE OF CONDUCT**

1. No smoking (anything, anywhere, anytime).

3. Track uniform will be worn when designated by chaperones/coaches.
4. Chaperones/coaches will know the locations of every athlete at all times, if they leave a designated area. Athletes are in no way permitted to tour outside the designated area at their leisure.
5. Every athlete must travel with the group at all times. No private forms of transportation will be allowed without prior expressed permission.
